

# The Pearl Award

## *Purpose of the Award*

Established in 2005, the Pearl Award is annually presented to a female member for assisting with initiatives for women, the labour movement and their community.

It is named after Local 1000A President Pearl Sawyer in recognition of her role as a trailblazer for women's rights in the union and the workplace. Sawyer was chosen as the first recipient of the award in 2005.

## *How is the recipient selected?*

The provincial WIN committee accepts and reviews all nominations for the Pearl Award. Based on the nomination applications, the committee will determine the recipient for the current year. The award is presented at the annual Stewards' Conference.

## *When is the deadline?*

Completed nomination forms must be received no later than August 14.

## *Who is eligible?*

Women who work full-time or part-time and are members in good standing of UFCW Canada Local 1000A.

Pearl Sawyer grew up in Charlottetown PEI, a province not normally known as a labour hot-spot. She went directly from the University of Prince Edward Island to work at Canada Packers, where she quickly became a workplace



activist and steward. She went on to become secretary-treasurer of the PEI Federation of Labour where she became active within the New Democratic Party. She moved to Ontario and became the first UFCW Canada member of the Ontario NDP executive. In 1982, Sawyer was hired as a Local 1000A organizer. Once on staff, she developed the stewards training program for the local and became the local's expert in matters relating to Worker's Compensation and Health & Safety. She held the post of Executive Assistant to the President until 2000 when she was elected Executive Vice-President. She became president of Local 1000A on July 1, 2011. Sawyer is currently the longest serving vice-president of the Ontario Federation of Labour where she co-chairs the Health and Safety and Workers' Compensation Committees. She is a graduate of the Labour College of Canada, has served as a labour director on the board of the Institute for Work and Health as well as being a board member, representing workers, at the bipartite Workplace Safety and Insurance Board.
